- Friday setup, noon to 6:00 p.m., is encouraged. You may also set up from 6:00 am to 8:00 am Saturday.
- Plan to stay until 3:00 pm Saturday; vacate your space no later than 6:00 pm. Please remove blue tape & # from floor before leaving.
- Electric heaters and fans are allowed. Tables are available to rent for \$10 each.
- Free removal of unsold items is available at the end of the event; all items left are donated to a local non-profit.
- The Events Center is in Kerr County; the sales tax rate is 0.0675.
- Official opening time is 8:00 am. Please be ready for customers no later than that time.
- **There are no refunds for cancelled dates; if notice is received at least 72 hrs in advance, fee may be “Rolled Over” one (1) time and, based on space availability, applied to a future date within the same calendar year.**
- This is an “open” event with all types of merchandise allowed except NO ALCOHOL and NO LIVE ANIMALS.
- We may require immediate removal of any item(s) not deemed appropriate.
- No partisan political booths are allowed; alcohol consumption is prohibited.
- Concessions are available; this is a pet friendly event.
